- Sub: Merger of pay scales of diploma holder Overseer with the Promotional Post of Superintendent BR-II/EM II and up gradation of pay scale of diploma holder Charge Mechanic/Electrician.
- Ref: This office letter No.CC/026/DO II dated 19th March 2009, even number dated 17.9.2009 & PAO/GREF/IRLA/LG dated May, 2010 forwarding the statement of Accounts for QE 11/09.

The format for notifying the pay fixed notionally on 01.01.2006 in the upgraded scale of Rs.5000-8000 in respect of all diploma holder Overseer, Superintendent BR-II/EM II and Charge Mechanic/Electrician with description 'UPGRAD' was circulated under this office letter dated 19.03.2009. All units were informed vide this office circular dated 17.09.2009 that the Grade Pay of the above categories of personnel would be reduced from Rs.4200/- to Rs.2800 & 2000 as applicable to non diploma holders in QE 11/09 and the Grade Pay of Rs.4200/- would be admitted only in respect of personnel for whom the DO II with description 'UPGRAD' were received.

While closing for QE 11/09, it was observed that many IRLAs of the above categories of personnel had closed with debit balance. All units/formations were again requested vide this office letter dated March, 2010 to forward DO II with description 'UPGRAD' by 15.03.2010 to enable this office to allow the correct pay in QE 02/2010. The IRLAs for QE 02/2010 has since been closed and it is observed that out of total 3099 personnel belonging to the above categories, DOIIs have been received in respect of 559 individuals only. As a result, the IRLAs of many of the above mentioned categories have again closed with debit balance in QE 2/2010. The list of personnel in respect of whom the DOIIs have not been received is enclosed, It is, therefore, once again requested to publish DOII with description 'UPGRAD' in case of Diploma holder Overseer/Superintendents, Charge Mechanic & Charge Electricians and forward the DOIIs in separate covers with heading as "UPGRAD DOIIs" addressed to Mrs. Rosamma Thomas, Sr.AO, by name. While publishing the DOII, the Basic Pay arrived notionally at as on 01.01.2006 in the pre revised scale of Rs.5000-8000 should be indicated in the rate column. It is requested that the DOIIs may be forwarded to this office by 28.05.2010. However, it may please be ensured that the DOIIs are not published in case of non-diploma holders.

Necessary instructions may please be issued to all the units under your Command.
